

RESOLUTION NO. 2012-01

**A RESOLUTION OF THE CITY OF BROOKSVILLE,
FLORIDA, AMENDING THE NAME OF THE MONTHLY
BEAUTIFICATION AWARD; PROVIDING FOR CONFLICT,
SEVERABILITY AND AN EFFECTIVE DATE.**

WHEREAS, Margaret R. Ghiotto, a lifelong resident of the City of Brooksville, who undertook as a personal goal the beautification, restoration and preservation of various portions of our community, adopted; and,

WHEREAS, through her own initiative, Mrs. Ghiotto undertook the restoration of numerous historic homes within the City of Brooksville, including, but not limited to, the Scarborough House and various homes on Olive Street; and,

WHEREAS, through all of her actions, Mrs. Ghiotto embodied and exemplified the true spirit of beautification of the City of Brooksville; and,

WHEREAS, Council adopted Resolution No. 97-02 designating the name of the monthly Beautification Award which is presented to local homeowners and businesses in recognition of improvements to property within the City as the “Margaret R. Ghiotto Beautification Award”; and,

WHEREAS, the Beautification Board wishes to change the name of the award to the “Margaret R. Ghiotto Improvement Award”.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BROOKSVILLE, FLORIDA, that the name of the Beautification Award shall hereafter be known as the:

“MARGARET R. GHIOTTO IMPROVEMENT AWARD”





SECTION 3. EFFECTIVE DATE. This resolution shall be effective upon adoption by the City Council of the City of Brooksville, Florida.


