A bid opening was held at approximately 3:00 p.m. on Friday, May 22, 2015, at the City Hall Council Chambers, 201 Howell Avenue for the **Veterans Avenue Paving Project**. Janice L. Peters, City Clerk, Richard Radacky, Director of Public Works, Joe Nelson, Streets Supervisor, Jon Dowler, Project Manager, along with Dale Ravencraft and Alan Garman of GPI were in attendance.

City Clerk Peters indicated the request for bids notice was published in the Tampa Bay Times Hernando Today Section on Friday, May 1, 2015. A mandatory pre-bid meeting was held on Wednesday, May 13, 2015. She stated bids will only be accepted from companies in attendance at the pre-bid meeting.

As a result, five (5) sets of bids/proposals were received, all properly sealed and notated. The bids/proposals were to include one (1) unbound original plus three (3) copies, which includes the Bid Certification Form, 5% Bid Bond, Proof of Insurance, Public Entity Crime Statement, Drug-Free Workplace Certification, State of Florida Contractor License, a list of sub-contractors to be used and a list of references for similar type work. Two (2) addendums were issued for this project and must be acknowledged in the bid packet submitted.
