

**GENERAL INFORMATION/BACKGROUND:** The City Council approved the purchase of a new Fire Department Engine / Pumper in the FY 2016 Budget. Per City of Brooksville Purchasing Policy, staff requests to complete the approved purchase utilizing Florida Sheriff's Association State Bid Contract. Vehicle and equipment costs are as follows:

Vehicle Install Equipment	\$ 437,596.55
Options +/- and equipment	\$ 34,690.09
Pre Pay Discount	(\$ 3,560.84)
<b>Total Purchase Price</b>	<b>\$468,725.80</b>

The Fire Department will surplus the existing 1999 American LaFrance Engine/Pumper Truck and through auction/appropriate means sell the vehicle to help offset the purchase price of the new Fire Department Engine/Pumper.

We are currently seeking to finalize funding arrangements, including grant availability through the Florida United States Department of Agriculture (USDA), and available financing options. We expect to hear from USDA soon regarding any allowance of grant monies and we will finalize any required financing options. We will return to City Council for finalization on the details of the purchase, prior to delivery of the vehicle (we expect to return not later than March 2016). We are requesting approval of the purchase from City Council now, so that we may place the order for the vehicle and avoid a "new year" vehicle price increase that could amount to approximately \$20,000. Delivery of the vehicle is not expected until June/July 2016.

**BUDGET IMPACT:** The City Council approved the purchase of the Fire Department Engine/ Pumper in the FY 2016 Budget with a \$220,000 down payment found within line item 143-014-522-55650. Other available funding and financing will be utilized to complete the purchase.

**LEGAL REVIEW:** City Council has home-rule authority (Art. VIII, 2(b), Fla Const./Section 166.011, F.S.) to consider matters of fiscal and intergovernmental benefit. Pursuant to Section

5.04 of the City Charter, competitive bidding is required except to the extent that Council authorizes otherwise by ordinance. Pursuant to Section 2-304 (a) (1) and (2) of the Code of Ordinances, the amount of expenditure for which the City may obligate itself without competitive bidding by the City is increased provided: (1) the City Manager recommends to the City Council that a specific purchase be made by piggybacking on an award by another governmental entity's competitive bidding process; and (2) the other governmental entity's competitive bidding process provides substantially equivalent guarantees of fairness and competitiveness to those of the City.

**STAFF RECOMMENDATION:** Staff recommends Council approve order placement for the purchase of the Fire Engine/Pumper as outlined above utilizing Florida Sheriff's Association State Bid Contract for a not-to-exceed amount of \$468,725.80.

**DATE: DECEMBER 22, 2015**

**GENERAL SUMMARY/BACKGROUND:** Reconstruction of Veterans Avenue was a huge undertaking due to the condition of the roadway, unsuitable base and drainage problems. The sidewalks were cracked, uneven, and of various widths. The roadway was riddled with potholes, had insufficient asphalt, and the surface was heaving due to shrink and swell of the sub-base. Veterans was considered by many to be the worst traveled roadway in the city. Now, after reconstruction, it is without a doubt the best roadway in the city.

Veterans Avenue receives an abundance of traffic including heavy fire and rescue vehicles, garbage, and construction trucks. Veterans Avenue also provides access for the City's Fire and Rescue, and Police Department. It is used as shortcut for general traffic from Jefferson Street (State Road 50) to Broad Street (U.S Highway 41).

Road reconstruction began in mid-July 2015, and was completed in mid-November 2015. The contractor was Goodwin Brothers Construction, Inc., of Brooksville. Goodwin did outstanding work on this project.. They communicated closely with Public Works' staff on many unanticipated and differing site conditions which occurred.

Road improvements included three (3) inches of asphalt where normally two (2) inches is standard. Other improvements included replacement of the existing base with crushed concrete, concrete curbing on the west shoulder, pavement markings, drainage structure modifications, and sidewalk additions and modifications.

The original bid price for this project was \$394,426.87. Upon completion, the final cost was \$477,103.45, which is an increase of \$82,676.58 or 20.9 percent above the original contract price. The subsurface was the most significant cost overrun and required the

removal of trash, marl, limerock tailings, and trees buried in the roadway with backfill of crushed concrete. Costs were as follows:

- Plans called for removal of 2,130 cubic yards of unsuitable soils and trash, to be removed and replaced with crushed concrete to provide a satisfactory base. A total of 755 cubic yards of additional unsuitable material were removed throughout the roadway and replaced with crushed concrete for an additional cost of \$65,192.58. The increase is 16.5 percent. The most significant removal was from Broad Street to Benton Avenue.
- The sidewalks from Broad Street to Benton Avenue required extensive modifications to comply with the Americans with Disabilities Act Standards; and to make pedestrian travel safer. This was 429 square yards (772 feet) of new sidewalk at the same unit bid price for an additional cost of \$15,061.69. The increase is 3.8 percent. Much of the existing sidewalk needed to be replaced due to extensive cracking and unevenness, which presented safety concerns. (Staff was able to negotiate a lower unit price with the contractor which resulted in a savings of \$2,432).
- A total of 69 square yards (124 feet) of sidewalk had to be removed and replaced with new sidewalk to conform to the height of the new concrete curbing, for an additional cost of \$2,422.31. The increase is 0.6 percent.

**BUDGET IMPACT:** The adjustment of quantities will result in an increased expenditure within the Fund 308 Fund, Transportation Capital Expenditures. Currently, \$125,665 is available within the Capital Outlay line-item in Fund 308 for FY2016, following first quarter completion of Council approved projects. Approval of this expenditure will result in a line-item balance of \$42,989.06.

**LEGAL REVIEW:** The City Council has Home Rule Authority (Article VIII, 2(b), Florida Constitution/Section 166.011, Florida Statutes) to consider matters of fiscal benefit.

**STAFF RECOMMENDATION:** Staff recommends that the Council approve the increased cost of \$82,676.58 for the Veterans Avenue road and sidewalk reconstruction project which is an increase of 20.9 percent. The revised total cost of the Veterans Avenue reconstruction will be \$477,103.45.

**GENERAL SUMMARY/BACKGROUND:** This memorandum and attached budget documents have been prepared in follow-up to the Red Light Camera Settlement Agreement with Sensys America. City Council agreed to extend the existing Red Light Camera Program until October 31, 2016.

When the fiscal year (FY) 2016, budget was adopted, the program was expected to terminate as of December 31, 2015; therefore funding (including revenues and expenditures) were only projected and budgeted through that time.

Because the program will now extend through the end of FY2016, the City's budget must be amended to provide for a projection of anticipated revenues and the offset expenditure requirements for program operations. Additionally, we have projected that any monies available from the program would be distributed to the Transportation Capital Fund (Fund 308) for Pavement Management/Capital Outlay projects directed and approved by City Council. This will require an adopted budget amendment by the City Council.

Budget amendment forms are attached for the following requested amendments:

1. Amend Red Light Camera Fund – 128 in the amount of \$770,000. Amendment attached increases revenues and expenses in the amount of \$770,000 due to extending the program through the end of the current fiscal year.
2. Amend Transportation Capital Fund – 308 in the amount of \$104,091.67. Amendments attached increases revenues and expenses in the amount of \$104,091.67 due to extending the program through the end of the current fiscal year.

**BUDGET IMPACT:** The budget impacts are reflected in the above summary for requested amendments and reflected on the attached Budget Amendment Forms for FY 2016.







**GENERAL SUMMARY/BACKGROUND:** City Council recently approved certain annexations into the geographical boundaries of the City of Brooksville. We have received correspondence from the Hernando County Board of County Commissioners, County Administrator, Leonard Sossamon stating objection to five (5) of the City's recent annexations. This letter is provided as attachment 1.

We are interested in discussing this correspondence and will seek direction as to appropriate response during our January 4<sup>th</sup> Regular Session.

**BUDGET IMPACT:** None at this time.

*CT* **LEGAL REVIEW:** As provided in Florida Statute Section 166.021 (1) and as outlined in the City of Brooksville's Charter the City shall have all governmental corporate and proprietary powers necessary to enable it to conduct municipal government, perform municipal functions, and render municipal services, and may exercise any power for municipal services unless expressly prohibited by law. Additionally, Florida Statute Section 171.044 specifically allows property owners or their duly appointed representatives to petition a municipality to annex their property into the municipality. The City Attorney has reviewed the annexation petitions and ordinance for legal sufficiency.

**STAFF RECOMMENDATION:** Staff requests City Council direction.


The Hernando County Board of County Commissioners has discussed the annexations recently enacted by the City of Brooksville and would like to state a formal objection to the annexations identified herein as follows:

1. Key 419096 - 20366 Cortez Blvd owned by Grace World Outreach Church, Inc.; and
2. Key 357893 - 20428 Cortez Blvd owned by Diocese of St Petersburg (St Anthony Catholic Church); and
3. Key 358437 - 20180 Barnett Rd owned by Hernando County Housing Authority (Magnolia Gardens Apartments); and
4. Key 1251031 - 1032 S Mildred Ave owned by Samuel and Kellie Griffin; and
5. Key 201490 - 6197 Broad Street (approximately 2,050 feet north of Southern Hills Boulevard) Brooksville Christian Church, Inc.

Annexations listed above as 1, 2, 3 and 4 were previously reviewed by the Planning Department for compliance with the Interlocal Agreement governing the first right to serve with water/and or sewer service, and the County's ability to serve these properties; and issued a letter of "no comment" for the proposed annexations relative to those planning issues. To date, the County has not responded to Annexation 5 listed above.

Upon review of the proposed annexations by the County Attorney's Office, and subsequent discussion with the Board of County Commissioners, the following concerns are being formally lodged for consideration by your office and the Brooksville City Council relative to the annexations identified in this letter:

1. The proposed annexations may not be consistent with the definition of compactness in Chapter 171.031 (12), Florida Statutes whereby the annexations should not create enclaves, pockets or fingers in serpentine patterns. Areas that are not reasonably compact may adversely affect the provision of services to the citizens by both City and County governments.

- 
2. The proposed annexations may not be consistent with the definition of contiguous in Chapter 171.031 (11), Florida Statutes whereby a substantial part of a boundary of the territory sought to be annexed is coterminous with the City boundary.
  3. The proposed annexations may not be consistent with Chapter 171.044, Florida Statutes whereby land shall not be annexed through voluntary annexation when such annexation results in the creation of enclaves.
  4. The annexation of Key 358437, taken in conjunction with the annexations of Keys 419096 and 357893, creates a finger of unincorporated land.
  5. The annexation of Key 1251031 creates an enclave of unincorporated land.
  6. Key 201490 (6197 Broad Street, approximately 2,050 feet north of Southern Hills Boulevard), Brooksville Christian Church, Inc. is not located within the City's the first right to serve with water/and or sewer service.
  7. The City should reconsider its actions on the annexations identified herein relative to the issues identified.






Grace World Outreach Church


- City Boundary






Hernando County Housing Authority

City Boundary



In accordance with the Department of Economic Opportunity's Evaluation and Appraisal Notification Schedule 2012-2018, the City of Brooksville hereby provides notice to the State Land Planning Agency that we have evaluated the City's Comprehensive Plan in accordance with Chapter 163.3191(1), F.S. and determined the Plan is in substantial compliance with State Statutes. Notwithstanding the above determination, the evaluation revealed the need to analyze the Future Land Use Element in order to ensure that the City has the "minimum amount of land required to accommodate the median projections of the University of Florida's Bureau of Economic and Business Research for at least a 10-year planning period...." The result of the analysis will determine if amendments to the Comprehensive Plan are necessary. Additionally, text changes will be required to delete references to Rule 9J-5 and to incorporate new statutory citations.

Despite the fact that we have determined the Comprehensive Plan is in substantial compliance with State Statutes, the City intends to modify portions of the Plan not identified in our initial evaluation. The amendments will focus on incorporating a vision for the City developed recently by a grassroots group of stakeholders. As expressed by the stakeholders and endorsed by City Council, the vision document was written with the intent of using it as a guide for future modifications to the City's Comprehensive Plan. The vision document contains guiding principles for land use, transportation, housing, conservation and open space, public safety, economic development, urban

design and public facilities. In addition to incorporating the guiding principles of the vision document in the Plan, the City intends to improve the Plan's clarity through structure and terminology that better conveys core principles, goals and interrelationships, and will identify and relocate regulatory-type policies to the appropriate regulatory documents such as the Land Development Code. Finally, the City intends to update the appropriate baseline information for each Element as necessary.

The Department has completed its review of the proposed comprehensive plan amendment for the City of Brooksville (DEO Amendment Number 15-1ESR), which was received on November 16, 2015. This package includes text amendments to the City's infrastructure and Intergovernmental Coordination Elements. The amendments adopt the Water Supply Facilities Work Plan by reference; and also ensure coordination with the water management district by updating the City's water supply plan within 18 months of the Regional Water Supply Plan. We have reviewed the proposed amendment pursuant to Sections 163.3184(2) and (3), Florida Statutes (F.S.), and identified no comment related to important state resources and facilities within the Department's authorized scope of review that will be adversely impacted by the amendment if adopted.

The City is reminded that pursuant to Section 163.3184(3)(b), F.S., other reviewing agencies have the authority to provide comments directly to the City. If other reviewing agencies provide comments, we recommend the City consider appropriate changes to the amendment based on those comments. If unresolved, such comments could form the basis for a challenge to the amendment after adoption.

The City should act by choosing to adopt, adopt with changes, or not adopt the proposed amendment. Also, please note that Section 163.3184(3)(c)1, F.S., provides that if the second public hearing is not held within 180 days of your receipt of agency comments, the amendment shall be deemed withdrawn unless extended by agreement with notice to the state land planning agency and any affected party that provided comment on the amendment. For your assistance, we have enclosed the procedures for adoption and transmittal of the comprehensive plan amendment.
